LIFE INSURANCE

Name Richmond County Hospice Foundation as a full or partial beneficiary of a life insurance policy.

RETIREMENT ACCOUNTS

Designate the Foundation as a beneficiary of an IRA, 401(k), or other retirement account.

BANK AND INVESTMENT ACCOUNTS

Name the Foundation as a beneficiary of an eligible bank, certificate of deposit, or investment account.

REAL ESTATE

Leave a home, land, farm, or other property through your estate plan.

STOCKS AND SECURITIES

Donate stocks, bonds, mutual funds, or other investments during your lifetime or through your estate.

DONOR-ADVISED FUNDS

Recommend that all or a portion of the remaining balance in your donor-advised fund benefit Richmond County Hospice Foundation.

NAMED OR ENDOWED FUNDS

Create a lasting fund in your name or in memory of someone special to support hospice care or a program meaningful to you.
