THE FIRST FIVE YEARS



In 1985 both towns of Rockingham and Hamlet and the hospitals in each town, as well as the County Commissioners, had come to the realization that our communities needed a hospice. This was a concept that was implemented in England by St. Christopher's Hospice and became the model for the growing movement in the US. Dame Cecily Saunders, OM, FRCP, MA, SRN, founded the modern day hospice care concept in 1967. It provided a place for the dying and their families to receive support when conventional medical treatment had nothing more to offer.

The first Richmond County Hospice Board made up of Richmond County leaders found inspiration in the words of Dame Saunders: "You matter because you are you. You matter to the last moment of your life, and we will do all we can, not only to help you die peacefully but also to live until you die." The word "hospice" means a community for sojourners along the way, a place for replenishment, refreshment, and care. The hospice concept was new to Richmond County and required the knowledge, devotion, and determination of these interested citizens to push it from idea to reality. The main idea was that this was a Richmond County project belonging to all the people of the county.

The next order of business for the Board was to hire an individual to coordinate the development of this project. Cordelia Steele of Sandhills Center for Mental Health, Mental Retardation, and Substance Abuse was chairperson of the committee to secure this coordinator. Cordeila and I had previously worked together, and she knew that I was currently not working. I had taken some personal time away from work to deal with and work through my grief since the tragic death of my sixteen-year-old son in an automobile accident. She called me and discussed the hospice project in the county and asked if I would be interested in applying for the position of Richmond County Hospice Coordinator.

While pondering this new proposal, I was led to realize that this was a perfect fit for me at this point in my life. I already knew that the best way to help oneself is to reach out and help another. I fully believe that everyone is a product of life experiences, and I felt that I had a great deal to offer to those who were going through life's journey and facing death. I completed my application for the job as the first paid employee of Richmond County Hospice. I met with the committee and was approved by the Board- Carole M. Venable, RN, FNP, Hospice Coordinator in July of 1985. This job required devotion, people skills, leadership, knowledge of many areas of nursing, medicine, teaching, budget development, typing, fundraising, and yes- begging. Obviously one person could not do all of this! Recruiting and training volunteers became one of my greatest projects. The help came from all areas of the county to include people with many talents. Many days and nights were filled with speaking engagements to various civic, church, and foundation groups. My family became my greatest assets- helping in whatever I needed.

There were legal issues such as acquiring a non-profit status; the lawyers' time was donated. Hospice of North Carolina led us in all areas of development. Judi Lund and Nina Cole were available by phone and frequent visits. Hospice of Randolph County shared many of their policies and procedures so that we did not "have to reinvent the wheel!" The generosity of our county continued to be revealed with the donation of a one- room office donated by Sandhills Center in the Goodman Building at 110 South Hancock Street. We really only needed space for one person, a phone, a typewriter, and a place to organize and accept donations.

The volunteer training was developed according to standards that were in place by the state. In the fall of 1985, the first class of fifty-four volunteers was taught the "Hospice Concept," and our policies and procedures were ready to be implemented. "Sharing in Caring" was our motto and underlying theme. By the use of volunteers, the contributions of the county, and the Duke Endowment, our services were provided for free. We used volunteer nurses to help care for patients and take care of "on-call" over the weekends so that I could rest and get ready for the next week. We began seeing patients in January of 1986 after we were licensed by the state.

Our one room became crowded, and we were allowed to expand into one more room as we began to collect supplies. We used a beeper to stay in touch with the office as we were out and about in the community. One of our volunteers from the first training class was the much loved Richmond County Daily Journal reporter Catherine Monk who frequently wrote excellent articles and helped introduce hospice to our community. With volunteers, Richmond County Hospice sent out newsletters, raised money, served patients/families, and grew. We grew so much that we needed to move down the street into rental space. In 1986, we hired a full time staff RN and LPN. We continued to meet many wonderful families as we served patients, and then many of these families volunteered to help. In 1987, we developed our first large fundraiser- The Festival in the Park. We had a coloring contest in the schools to invite the children out and to raise awareness of hospice. We sold barbeque and played games.

The Festival in the Park grew over the years to include a Celebrity Auction and involved the work of many, many volunteers. We had many fundraisers that were sponsored by local civic clubs and some that our volunteers did. As we became more developed, the need for administrative staff became evident. Dianne Newton was hired as Administrative Coordinator to join me and the nursing staff in our efforts to continue to grow and develop Richmond County Hospice. Hospice continued to grow and to provide quality end of life care to many people. "Sharing and Caring" impacted many people in our community, both ones receiving service and the volunteers. I count this as an honor to have been a part of Richmond County Hospice for the first five years of its life.

THE FOUR HOMES OF HOSPICE

Richmond County Hospice, Inc., was first housed at 110 South Hancock Street, Rockingham, in the Goodman Building in office space donated by Sandhills Center for Mental Health. Once the agency outgrew that space, it moved to an office on the corner of East Franklin and Hancock Streets.

After purchasing the office building at 230 South Lawrence Street in Rockingham, Richmond County Hospice moved to that site in April of 1992.

As the staff began to outgrow that location, the search began in March of 1998 for a permanent home.

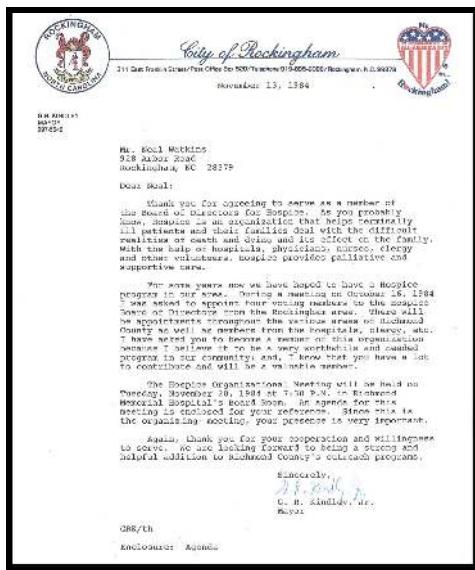
In August of 2001, Richmond County Hospice moved to its current location at 1119 N US Hwy 1 and opened Hospice Haven in February 2002.

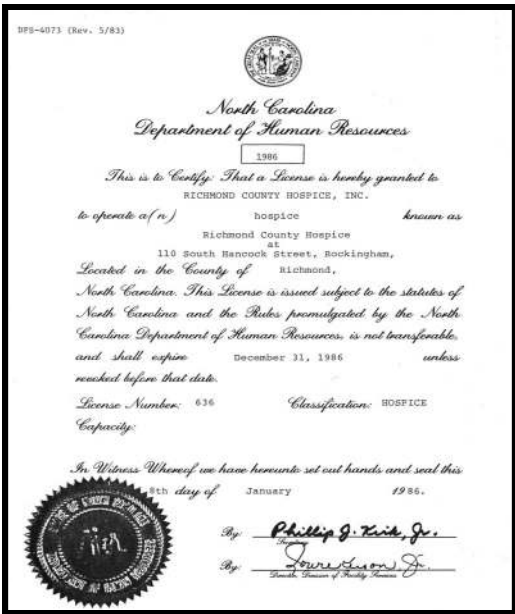

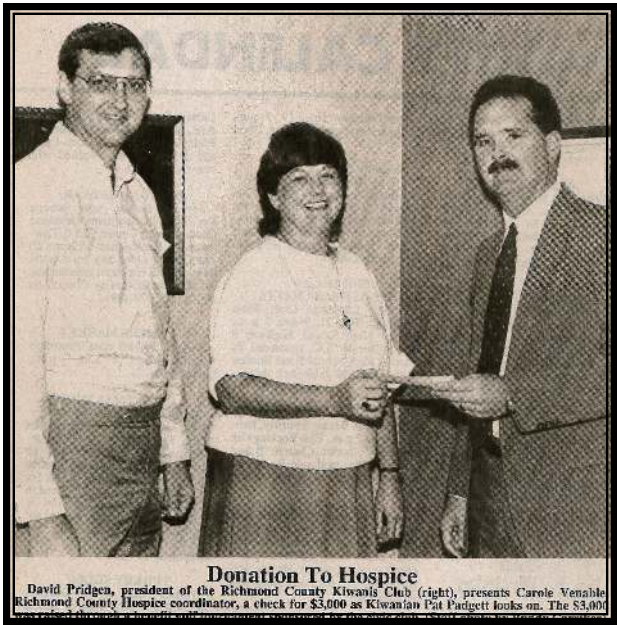

Hospice launches capital campaign to build new center

More than 500 guests gathered at the Galla Community Center Thursday evening to celebrate the launch of a \$2,200,000 capital fund-raising campaign for Rockingham County Hospice.

The campaign is an effort to fund construction of Hospice Center for Compassionate Care. The center will be created on a 25-acre site north of Rockingham. It will include two buildings – Hospice Center, a new headquarters for Hospice, and Hospice Haven, a residence where hospice patients who cannot be cared for in their own homes will be able to stay while hospice cares for them.

The featured speakers at the celebration were Gary Fisher, chairman of Hospice's board; Diane Newton, Hospice's executive director; and Gene McLaurin, chairman of the campaign.

Fisher said that the evening was a celebration of the work that Rockingham County Hospice has been doing for 13 years. "Someone you know has been touched by Hospice," he said.

Fisher emphasized that the Hospice board is looking ahead. The large new campus has been planned to allow Hospice to grow and respond to changing community needs in future years.

Newton said that Hospice cares for people from all segments of the community – "wealthy people, poor people, and people in between." Hospice is caring for 100 patients at present. Newton observed that Hospice is a successful organization, and that this success is due to an outstanding board, a hard-working and caring staff, and a highly supportive community.

McLaurin introduced a campaign video that included interviews with people whose families had been served by Hospice.

"Hospice is about helping people in a time of need. As you decide how much you are going to contribute to the Hospice Campaign, please think about what you heard here tonight from people Hospice has helped. It's our turn to help Hospice."

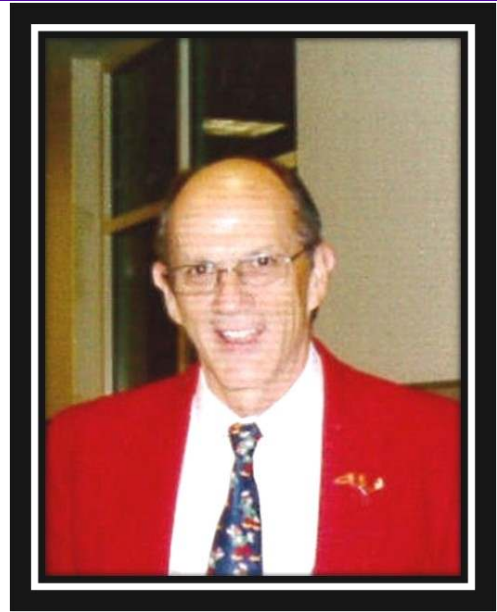

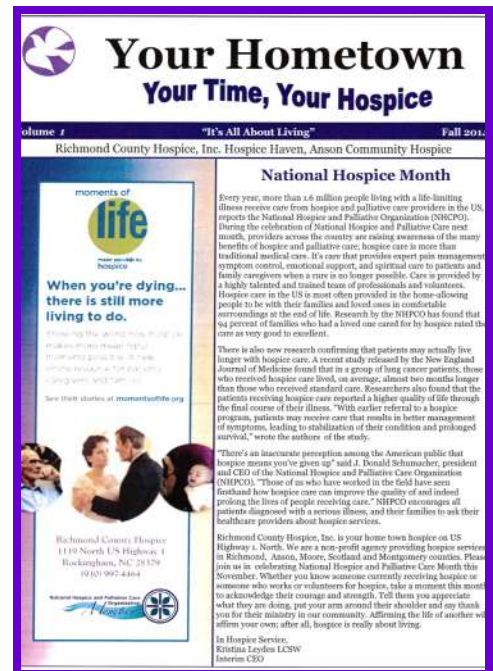

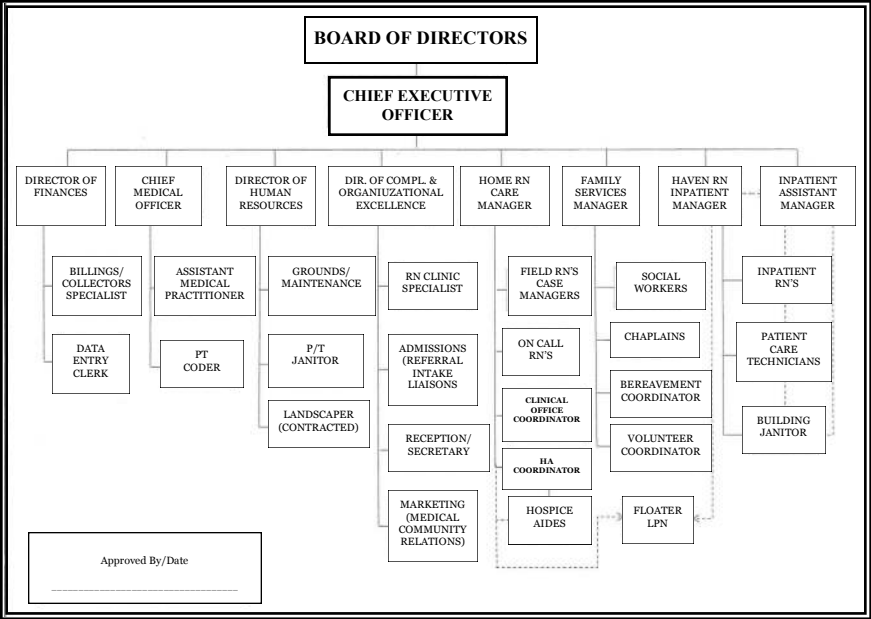

Making History with the First Board members of Richmond County Hospice.

On November 13, 1984, the then Mayor of Rockingham, G.R. Kindley, Jr., sent out letters to community members asking them to serve as a board member and attend the community Hospice Organizational Meeting. This first board meeting was held on November 20, 1984, at Richmond Memorial Hospital's board room to begin discussion on establishing a County Hospice that would be supported by all areas of the County-Hamlet, Rockingham, Ellerbe, Hoffman, Norman, etc.



These individuals who were appointed as the First Board of Richmond County Hospice had the daunting task of establishing a hospice program. The members of the board were all volunteers and had to commit their time and level of expertise to establish a solid hospice program for our community. Their vision and hard work paid off; Richmond County Hospice was built on a grassroots effort and has flourished as an independent community based non-profit organization that services 80% of the county's hospice needs today.

As we look at our past and into our future, we are forever thankful to those who were part of these initial efforts to establish a county hospice for our community.

A LOGO HISTORY

A logo is a simple image that identifies a company via the use of a mark, flag, symbol, or signature. In general, it should be uncomplicated, basic and easy; it usually portrays what the company is about, its ideals, its name, and so on. A logo does not sell the company directly nor rarely does it describe a business. Logos derive their meaning from the quality of the thing it symbolizes, not the other way around – logos are there to identify, not to explain.

Many companies don't even need to use their names anymore; just by seeing the logo, they are immediately recognized. But to get to that point they have been through many changes, variations, and developments. During 30 years of existence, Richmond County Hospice has evolved in many ways and one has been through our logos. For us, what a logo means is more important than what it looks like.

During our thirty years of service, Richmond County Hospice has used five different logos:



This is the first logo that was used to represent Richmond County Hospice. It is the letters **RHC** (standing for *Richmond, Hospice, and County*) forming a house. The background is a map of the area where services were provided. The motto *Sharing and Caring* was adopted to portray what we were about.



About 10 years later, this logo was modified and simplified to contain only the acronym **RHC**, but still "covered" with a "roof" forming a house- a shelter, a refuge, a haven. The map was removed so we would not be limited to that geographical area only.



During a capital campaign fundraising for the construction of our actual facility, a new logo was used, during 2000. This was evident in all the literature announcing the upcoming construction. This special logo was no longer used after this special campaign.



Our third logo came to be around 2004. It was a total transition from the initials, showing an image of a frontal dove, which has for ever been a sign of peace and purity. This change came with a modification to our motto, becoming now ***Peace, Comfort and Dignity***. This logo was used for several years and was in sync with the color theme of our building's decor.



At one point during 2006 the same logo changed only in colors, from the pink background to a greenish one, but everything else remained the same



In late 2000, Richmond County Hospice applied for a license to serve Anson County, and in order to reflect this change the following logo was adopted, which now reflected that we were not exclusively serving Richmond, but also Anson County. In reality we always served not only Richmond and Anson counties, but also Scotland, Moore and Montgomery counties.



For some time, still trying to find our own identity, we were using interchangeably the last three versions of the logo since they still represented our motto and the fact that we serve more than Richmond County.

Finally in 2014, a new logo was designed to represent Richmond County Hospice

Hospice Haven

On Thursday June 28, 2001, there was a large campaign ad in the Richmond County Daily Journal that read “ **YOU CAN MAKE ALL THE DIFFERENCE...AS YOU CONTINUE YOUR CONTRIBUTIONS TO HOSPICE, REMEMBER WHAT A VITAL ROLE YOU PLAY IN THIS CARING ENDEAVOR.**” You may not fully realize what a difference you are making in the life of your hospice, but each of you nurture this organization in your own special way. The role you play is instrumental in the survival of your Hospice. Looking over the history of hospice in the last few weeks for this special edition, the community, YOU, made the difference 30 years ago in establishing a grassroots effort to begin a county hospice and then 14 years ago in building the new Hospice Center for Compassionate Care which included the administration building and the Hospice Haven. The staff and the community were able to raise the needed costs, including grants, and personal business donations for this new campus.

Ground was broken in August, 2001, for the new six bed residential facility, Hospice Haven. The construction team completed the building in January 2002, and the building was licensed for residential hospice care on January 31, 2002. The doors then opened for care and this state of the art facility accommodated up to six hospice patients. Rooms were given to those patients who had the greatest need for 24-hour care. The residential facility was staffed by one registered nurse and two hospice aides during the day and two nursing aides at night. The Haven was a place patients could call home and live their last days or months when their home environment was poor or they did not have any caregiver to assist them. For the next 10 years, many in our community were able to call Hospice Haven their home.



In December 2011 the Board of Directors and then Executive Director, Mary Ellen Shea, made a temporary decision to close Hospice Haven Residential Center in efforts to refurbish the facility into a General Inpatient Unit. The decision was made to increase services to the community for acute hospice care services. The Haven went through a one year face lift and transformation to meet the regulations of a General Inpatient Center and to become licensed by Medicare for acute care services. In June of 2012, Kristina Leyden, now CEO, was hired to complete the transformation and licensed requirements for Hospice Haven. Hospice Haven was licensed on December 11, 2012, and admitted the first patient for General Inpatient Care on December 12, 2012. The Haven provides quality end of life care when a patient needs acute care for emergencies, uncontrolled pain, or symptom management that exceeds the scope of care that can be managed in the home. The General Inpatient Unit is staffed with two RN's, two hospice aides during the day, and one RN and one hospice aide during the night shift. In addition to floor staff, a full time social worker, nurse manager, hospice physician, and housekeeper complete the hospice haven team. Hospice Haven is the only General Inpatient Care Center in our county, and we feel honored to be able to provide these services to our community. In the words of one family member, "There is no place in Richmond County I'd rather have my mother. People need to know that it is a God send."

A WALK TO REMEMBER

In August, 2013, the beginning of the new walking trail began to be developed. The walking trail called “A Walk to Remember” was designed to be a path to give families, patients, and the community a place to walk, reflect, and remember. The project took two years to design, including clearing of the wooded area and initial gardens/walkways. The walking trail is a great addition to the Hospice Haven Inpatient Center and is adjacent to the Haven.

At the beginning of the trail, the patients are able to hear the comforting sounds from the water fountain which is surrounded by bricks donated by Hannah Pickett Mill. Passing the water fountain on the right, the trail winds around to the old fashioned wooden frame of a house that has a porch with rocking chairs to allow individuals to sit and talk or reflect while experiencing the soothing rocking motion. Continuing around the trail, there are benches, picnic tables, and a patio with a covered pergola.

The trail was created in the memory of Officer S. Bayne McLester, donated by her parents who funded the initial phase of this serene walking path. A private dedication ceremony was held on September 22, 2013, at 2:30 PM to celebrate and dedicate the gardens to Officer McLester and open them for the public use. At the end of the dedication, butterflies were released as a symbol of new life, change, and a new beginning.

Since the opening of our walking trail, others have added and donated to the gardens. A Wild Flower Garden was added by Lowe's Hero's; other flower gardens were added by Bobbi Irwin's family in recognition of Bobbi for being a Volunteer of the Year; the Men's and Women's club of the First United Methodist Church added a garden with St. Francis of Assisi.



In the future, we hope to add a Veteran's Garden to our walking trail and many other smaller gardens throughout.



GRIEF CAMP

The journey of grief is one that, at some point, touches every human life. Nothing is quite as tragic as when a child experiences grief. In response to this need, for the past twenty-four years, Richmond County Hospice has been proud to offer the Annual Children's Grief Camp. The theme for this event has changed, but the mission remains the same. This camp centers around provision of activities focused on dealing with grief for children who have experienced loss within the last year. The first grief camp, entitled, "Wind Beneath My Wings," was held at Browder Park on January 17, 1990. A variety of settings have hosted the annual camp including, Big Pine Retreat, Hinson Lake, and the campus of Richmond County Hospice. At one time, this event was held overnight at the Hermitage Retirement Center. The planning committee is comprised of the Richmond County Hospice Staff, local school counselors and social workers, and community volunteers. This committee serves to ensure that this day is a success for all campers. Local business support is also vital to the ongoing success of the grief camp. Businesses and individuals contribute financially and in-kind support to assist with this worthwhile endeavor. The present day grief camp, "Camp Haven," is held on the campus of Richmond County Hospice and features a variety of activities focused on allowing campers to connect with and express their feelings regarding their loss. This year's event, scheduled for April 22, will mark the twenty fifth year. Sandy Black, Bereavement Coordinator, emphasizes that the camp is not only for children who have experienced the death of a parent but also other types of grief and loss.

Volunteers-Heart of Hospice

Volunteers are a vital part of Richmond County Hospice, and we have been fortunate to have several give of their time and talents for the last thirty years. As a non-profit organization volunteer hours are required by Medicare, and those hours must match five percent of our paid clinical staff hours. On November 21, 1985, fifty four volunteers were honored for completing the first volunteer training at Richmond County Hospice. Although the training has changed much over the last thirty years, the goal to provide volunteer services to our patients and families remains the same. Volunteers, giving of their time and talents, continue to impact the patients and families and also Richmond County Hospice staff.

Lisa O'Neal, present Volunteer Coordinator talked with Mary Heavner, a volunteer since the early 1990's to find out what drives her to continue coming back to Richmond County Hospice all these years. Mrs. Heavner started volunteering at the first hospice location by helping with office type duties when she had the time. After having a personal hospice experience in 1996, she became a full time volunteer holding many different roles. Maintaining the donated supply room and leading the annual Bake Sale proved to be her talent.

In February 2005, she completed the patient care volunteer training and took on other tasks including preparing meals for patients and families at Hospice Haven and helping with children's grief camp. When asked what she gained from volunteering, she stated that she enjoyed volunteering with hospice as a whole and doing whatever needed to be done. In 2008, she received the Volunteer of the Year award, and, at that time, the award was named after her.

Although she may not be able to come as often now, as she once did, she continues to volunteer by preparing birthday bags for the patients, assuring that every patient we serve receives a little something on their special day. When asked what she would tell anyone interested in volunteering she shares, "that since her loved one passed away in 1996, visiting with patients and families at Hospice Haven has been some of the happiest times she's ever had." She has been a great asset to Richmond County Hospice, and we are forever grateful for her continued support.

Lisa also, talked with a previous volunteer Jessica Price Martin, about her volunteer experience with Richmond County Hospice. Jessica volunteered her senior year of high school, because she wanted to be able to help a teacher who had helped her tremendously when her grandmother passed away unexpectedly. Her volunteer role consisted of running errands and providing comfort to the primary caregiver, while she was caring for her dying loved one. She stated that she gained knowledge regarding the dying process, but mostly it became apparent to her how much an illness can affect an entire family. When asked what she would tell anyone interested in volunteering she shares, she would encourage them to do it! It's a wonderful way to give back to someone in need!

Richmond County Hospice has an incredible staff who are more than willing to help you along the way. Volunteer Coordinator, Lisa, asked Jessica her volunteering with Richmond County Hospice helped her decide her career path, Jessica stated that she had decided her career when she chose to become a volunteer but her time with hospice helped her when taking care of dying patients and families.

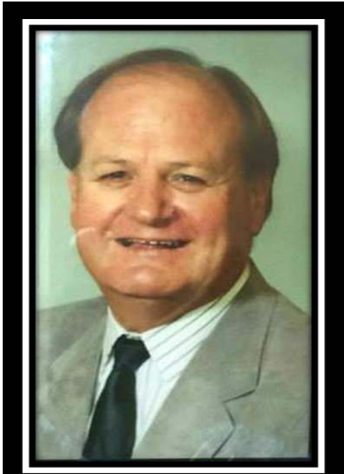
