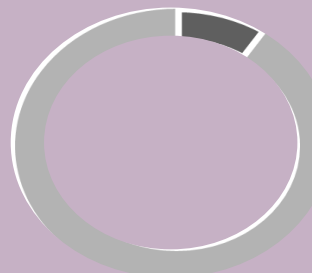

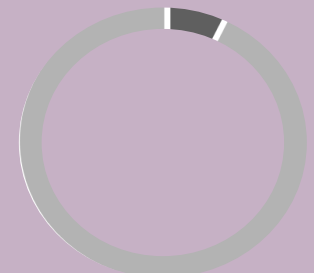

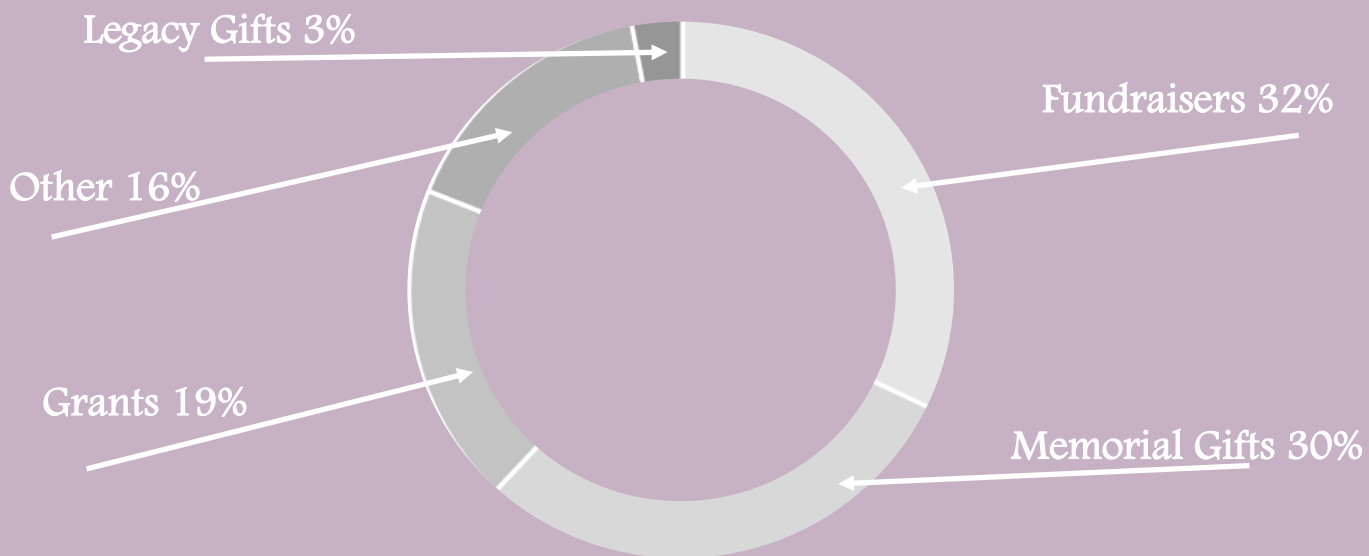

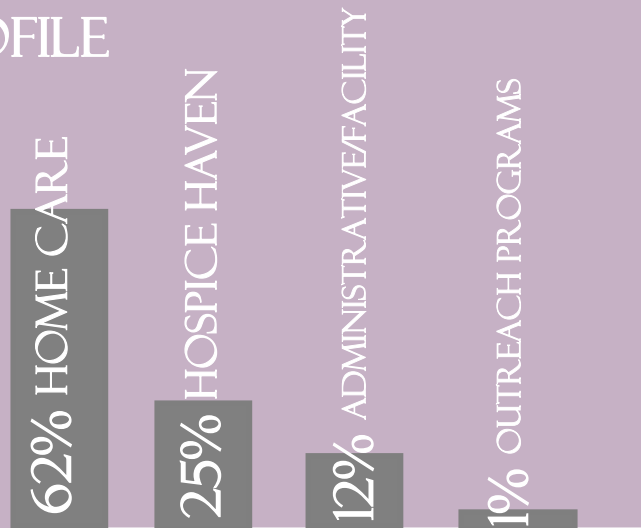

HOSPITALIZATIONS

Aiming to reduce hospitalizations for end-of-life patients may sound counter-intuitive, but this is typically the mutual goal of RCH and our patients as we provide the opportunity for patients to receive care in their homes. Approximately 25% of patients who disenrolled from hospice are hospitalized. And non-hospice patients who are terminally ill have hospitalization rates as high as 65%. RCH's hospitalization rate was 1.7% in 2019.

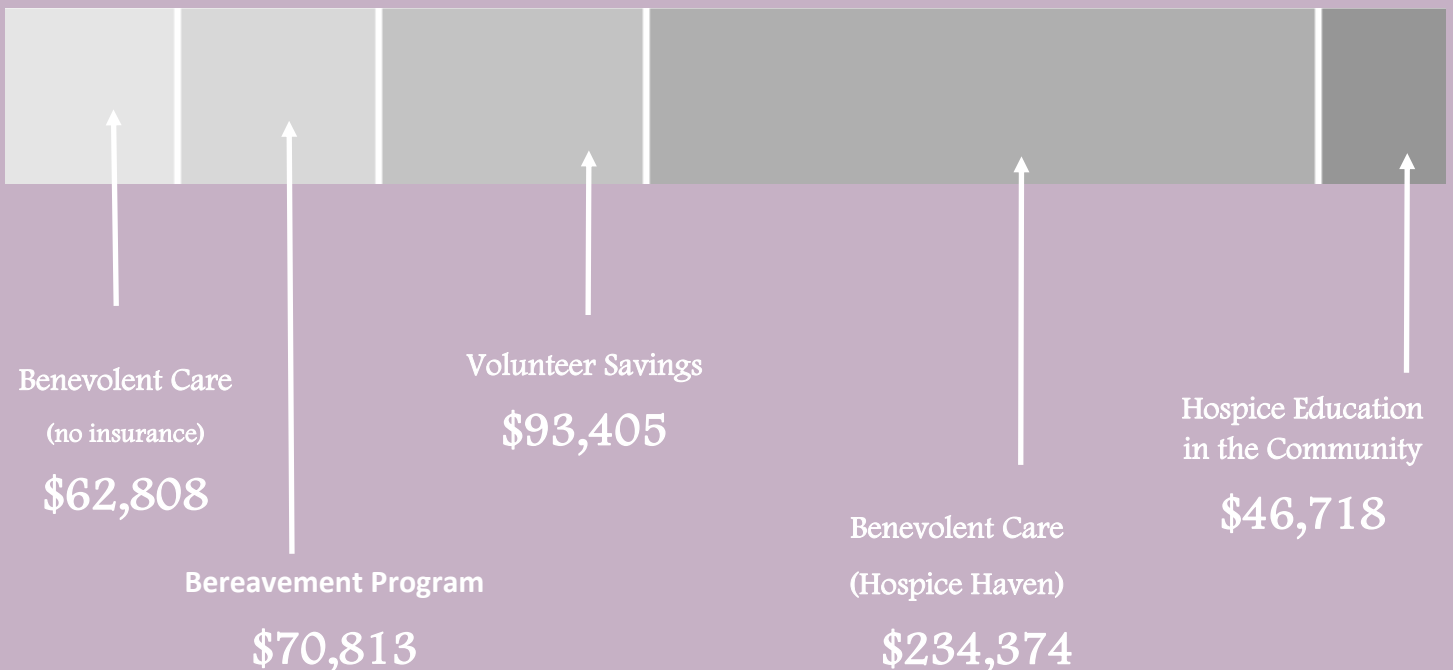
When hospice began in the U.S. in the mid-1970s, most hospice patients had cancer. Today, while many hospice patients have cancer, the majority have other life-limiting illnesses such as end-stage heart, lung or kidney disease, or Alzheimer's and other dementias.

AVERAGE LENGTH OF HOSPICE STAY

The No. 1 complaint that families report on hospice Consumer Assessment of Healthcare Providers and Systems (CAHPS) surveys is that they wish their loved one had entered hospice sooner, according to the U.S. Centers for Medicare & Medicaid Services (CMS). Medicare's hospice benefit offers six months in hospice, and people can go longer when there are extenuating circumstances. Expert consensus holds that people should receive at least three months in hospice for the full benefit of the hospice program.
