Veterans Garden Dedication Ceremony

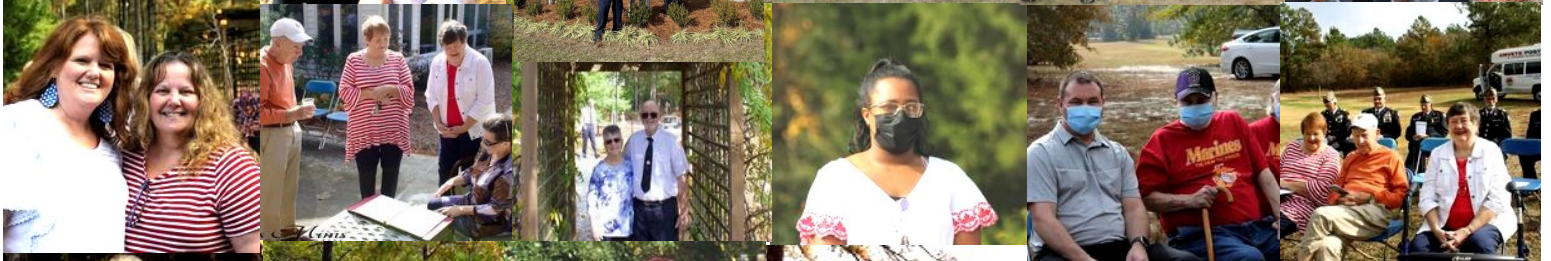
